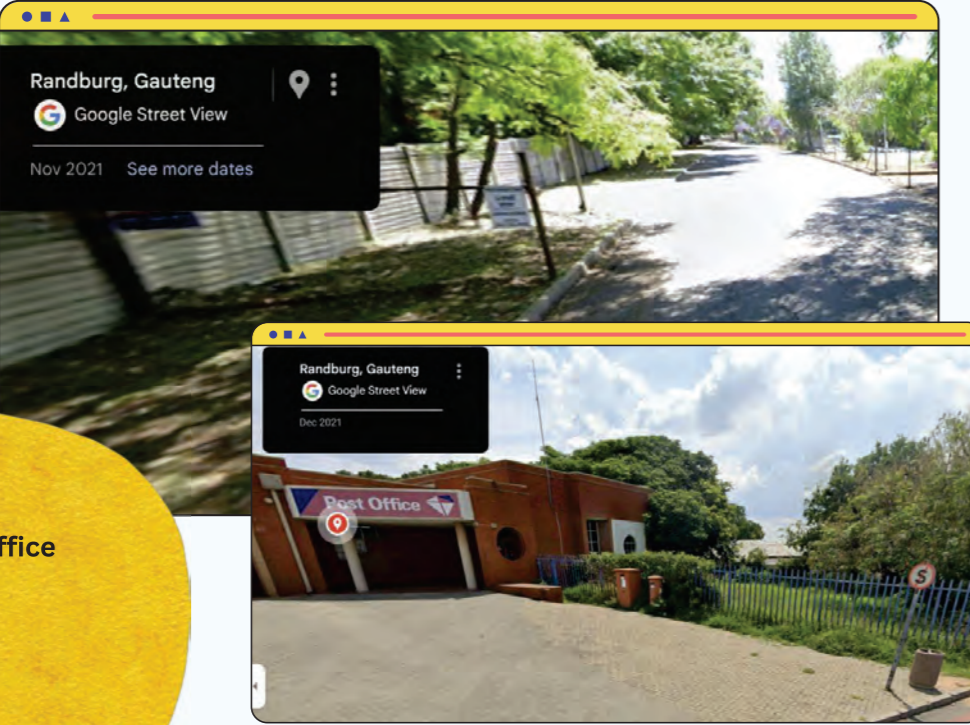
WHAT IS A HOT-SPOT?

A hot-spot refers to a specific area recognized as problematic due to a high frequency of incidents or attempted incidents of crime occurring within that location, whether it be a center, building, block, or park.

Hot-spots can shift or change quickly. Reporting any crime, even minor ones, aids in predicting crime trends and allows for targeted efforts by SAPS, CPF and Security Providers to address hot-spots.

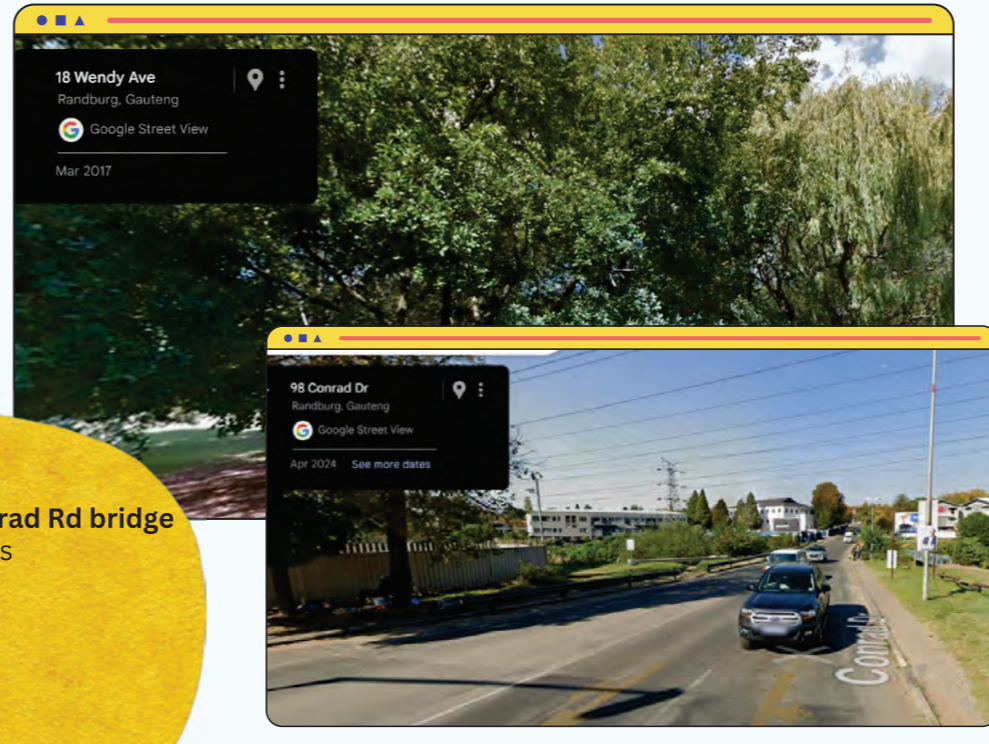

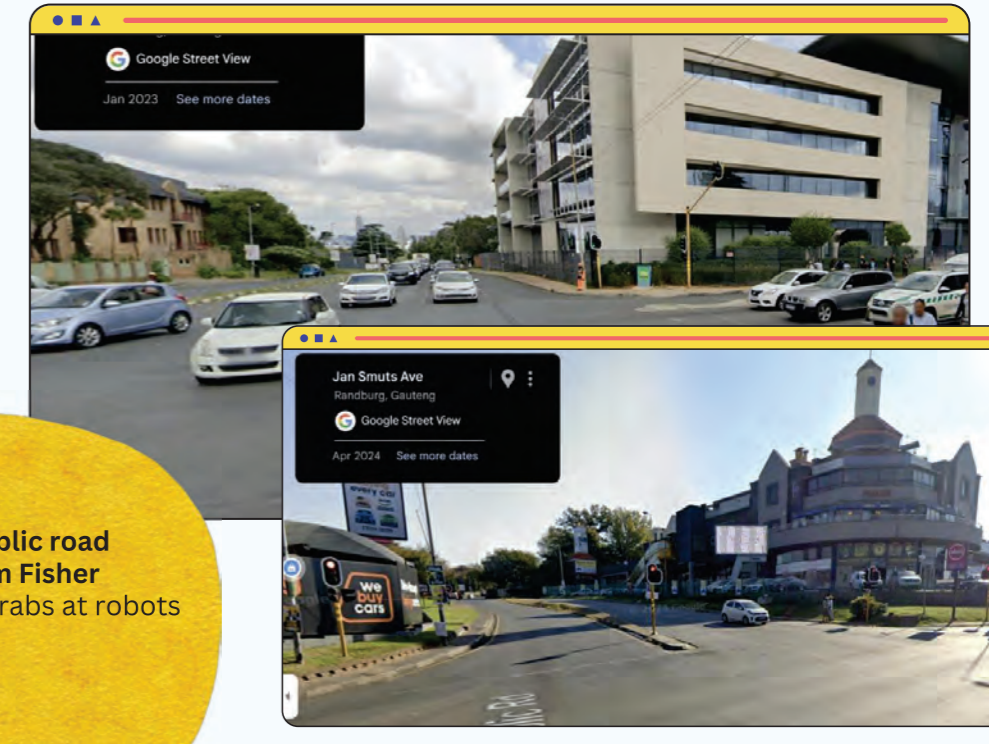

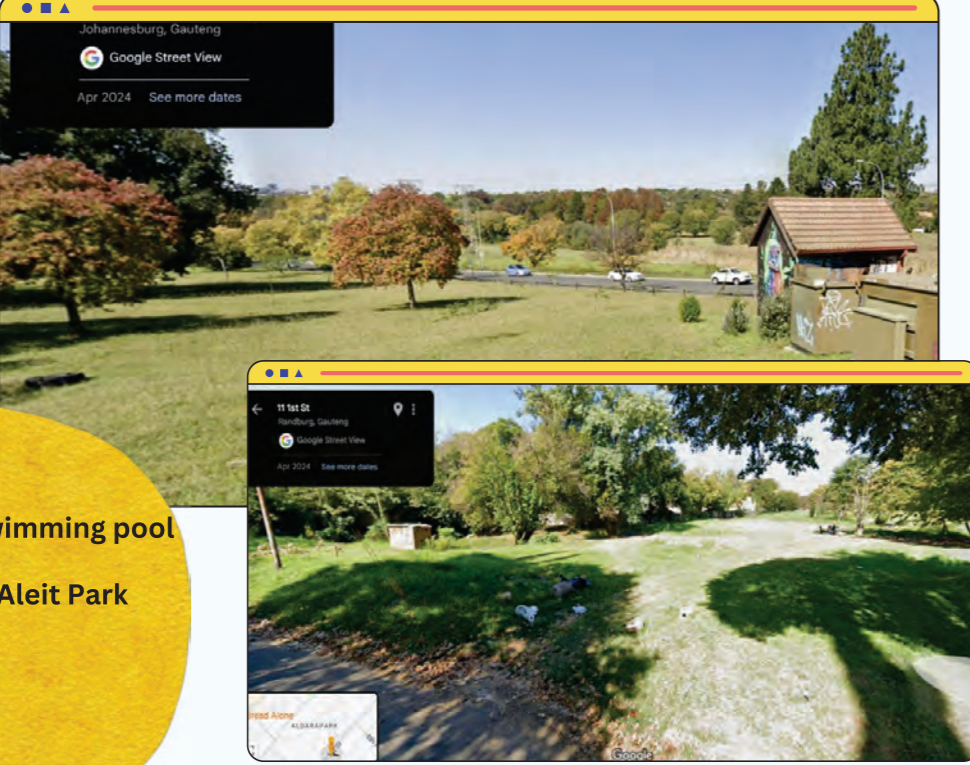
